- 1 When purchasing a ticket, any attendee agrees to the terms and conditions outlined below.
- 2 Nobody will be allowed admission to the ASM without payment. Once payment has been received, an email confirmation will be emailed to the attendee.
- 3 For the safety of everyone at the ASM, the venue management and BOAS reserve the right to refuse admission.
- 4 Badges will be issued on arrival to the ASM at the registration desk, and these must be worn at all times.
- 5 Tickets can be transferred to another individual or exchanged for a future event at the discretion of the Society. Please contact BOAS to ensure any changes are approved and registered.
- 6 If the ASM is rescheduled, moved or cancelled, BOAS will give you the option of either exchanging your tickets for the new date/location or a full refund. Please note that any Booking Fees and/or Transaction Fees are not refundable in these circumstances.
- 7 If the Event is rescheduled or cancelled, BOAS cannot be held responsible for any resulting costs you may incur for travel, accommodation and other services already booked. We kindly request you seek reimbursement directly from the travel provider or hotel.
- 8 BOAS reserves the right to change or vary the content and/or timing of any part of the event in circumstances beyond its reasonable control without any obligation to make any refunds or exchange tickets.
